## 3B. Project Description

### 1. Provide a description that addresses the entire scope of the proposed project.

The House-ability program is a collaborative effort between 3 homeless service agencies: The Salvation Army, The Road Home & YWCA. It serves very low-income (<30% CMI) families who are literally homeless & have at least one disabled household member. The House-ability Program follows principals of Housing First, which is proven to be successful. Participants aren't required to have income or maintain sobriety in order to be enrolled in the program and receive services. The House-ability program incorporates a set of interventions to help families move rapidly out of shelter (and/or avoid shelter) and maintain permanent housing.

The House-ability Program began in August 2008. The program aims to 1) move homeless families quickly out of homelessness and into affordable permanent housing, 2) help families successfully maintain stable housing and 3) assist families in working toward their personal goals. The program serves 23 families in permanent housing. Specific services provided in the program include: assistance in finding an apartment in the community, ongoing case management, security deposit assistance, payment of rent directly to the landlord, referral to employment & training services, & referral to tenant & financial education programs. Through regularly scheduled meetings, the program case managers work with enrolled families to set & attain goals leading to an increased level of self-sufficiency & stability. Concerns that might be addressed in case management sessions include: budgeting, clearing bad credit, increasing income, addressing and providing resources for parenting concerns, addressing and rectifying concerns regarding landlord/tenant rights/responsibilities, assessing and providing resources regarding household maintenance, addressing medical, dental, mental health, and/or substance abuse issues, referral to mainstream resources, and any other barriers that might put the family at risk of future homelessness.

Program participants are expected to pay a monthly program fee, if they have income. The House-ability Program Coordinator consistently reaches out to landlords and property managers to encourage them to accept program participants. Incentives are offered to landlords such as timely and consistent rent payments and funds available to help pay court costs and damages (up to 1 month's rent). If facing an eviction, the Program Coordinator and the Case Manager work to re-house the family as quickly as possible, while continuing to provide supports to the family. The House-ability Program is usually full. When there is an opening, we use the Prioritization List for PSH for families kept by our local Coordinated Entry which prioritizes based on chronic homeless status, length of homelessness & VI-SPDAT score.

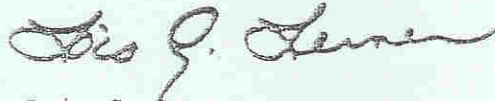

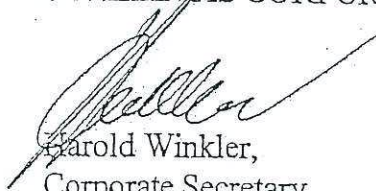
