- Updates from: City, County, United Way, Youth Action Board, Lived Experience Council
- City Updates: Linette Rhodes
 - YHDP funds came to the community, 3 years attempted at the funds (Federal Grants), City is the Lead Agency, asked for a Board Liaison commitment, currently Robin Sereno, Meshan Adams will pivot back to the Men's Shelter, have contacts with agencies.
 - Shelter and Planning Grant Purpose built Men's Shelter, 2nd round of public information meetings, will not get the CoC specifically b/c they were not well attended, 9/13/23, 9/20/23 and 9/21/23 starting at 1800 (1 virtual and 2 in person) will share what the outside will look like, asked for an increase of \$2 million to have a back up charger and additional floor space for programing (hopeful that the Common Council will approve, initially the proposal was \$43 million), would like a 24 hour shelter, will come down to the operating budget, there will be an increase in this cost, City's operating budget has not yet been published, complete in 2025, making sure that operating cost will be included in this.
 - Coordinator CoC funded Sarah Lim and Meshan Adams are funded in other grants, at this time able to hire a second Coordinator in 2025, starting the groundwork now. Once the job description is written will bring this back to the board. Hiring equity tool at the city will be used.

 - Latest numbers on H2H 16% exiting to homelessness, transitioning out of the program, CORE 2.0 still processing, EDDP, ERA Urban Triage will be processing these, RFPs for Doubled Up Way Forward
