3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Dane County's family shelters, which are offered by the YWCA and Salvation Army, serve families year round. During the busiest summer months, families may be waiting to enter shelter. Once in shelter, families have a difficult time finding permanent housing, often due to low or no income & previous housing-related difficulties. The House-ability program is a collaborative effort between 3 homeless service agencies: The Salvation Army, The Road Home & the YWCA. It serves very low-income (<30% cmi) homeless families who are literally homeless & have at least one disabled adult. The House-ability Program follows principals of Housing First, which is proven to be successful. Participants aren't required to have income or maintain sobriety. Housing First programs incorporate a set of interventions to help families move rapidly out of the shelter (or avoid shelter) and maintain permanent housing.

The House-ability Program, which began in August 2008, 1) moves homeless families quickly out of homelessness into affordable permanent housing, 2) helps families successfully maintain stable housing, 3) assists families in working toward their personal goals. The program serves 23 families in permanent housing. Specific services provided in the program include: assistance in finding an apartment in the community, ongoing case management, security deposit assistance, payment of rent directly to the landlord, referral to employment & training services, & referral to tenant & financial education programs. Through regularly scheduled meetings the case managers will work with the families to set & attain goals, leading to an increased level of self-sufficiency & stability. If facing an eviction, the Case Manager, Program Coordinator, and Housing Locator work to re-house the family as quickly as possible, while continuing to provide supports to the family. The House-ability Program is usually full. When there is an opening, we use the Prioritization List for PSH for families kept by our local Coordinated Entry which prioritizes based on chronic homeless status, length of homelessness & VI-SPDAT score.

However, if you lose your section 509(a)(1) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(1) organization.

You are required to make your annual information return, Form 990 or Form 990-EZ, available for public inspection for three years after the later of the due date of the return or the date the return is filed. You are also required to make available for public inspection your exemption application, any supporting documents, and your exemption letter. Copies of these documents are also required to be provided to any individual upon written or in person request without charge other than reasonable fees for copying and postage. You may fulfill this requirement by placing these documents on the Internet. Penalties may be imposed for failure to comply with these requirements. Additional information is available in Publication 537, Tax-Exempt Status for Your Organization, or you may call our toll free number shown above.




