**Available Funds:**

**Nationally:** \$2.1 billion available including \$50 million for Domestic Violence Bonus projects

**Locally:**

PPRN (Preliminary Pro Rata Need): \$1,663,997

Estimated ARD (Annual Renewal Demand): \$3,129,707

Estimated ARD at 94%: \$2,941,925

CoC Planning: \$93,891

Permanent Housing Bonus: \$187,782

DV Bonus: \$166,400

**Domestic Violence Bonus**

- Up to \$50 million for "rapid-rehousing projects and supportive service projects providing coordinated entry and for eligible activities that the Secretary determines are critical in order to assist survivors of domestic violence, dating violence and stalking"
- Can apply for up to 10% of Preliminary Pro Rata Need, or a minimum of \$50,000, whichever is greater, or a maximum of \$5 million, whichever is less, to create up to 3 DV Bonus Projects
- Can be one of the following projects
  - Rapid Rehousing (PH-RRH): must follow a housing first approach
  - Joint TH and PH-RRH: must follow a housing first approach
  - SSO Projects for Coordinated Entry to implement policies, procedures and practices that equip the CoC's coordinated entry to better meet the needs of survivors of domestic violence, dating violence, sexual assault, or stalking.
- Grant Term of one year
- Can only submit one project application for each project type
- Can expand an existing renewal project that is not dedicated to dv to dedicate additional units, beds, persons served or services provided to existing program participants to this population.
- Must rank all DV projects

- If selected for DV Bonus funds, will be removed from ranking list and all projects move up.
- If not selected for DV Bonus funds, will stay on list and be considered for any bonus funds that the CoC has available

#### **Consolidated Project**

- New in FY2018
- Eligible renewal project applicants will have the ability to consolidate two or more eligible renewal projects (but no more than 4 projects) into one project application during the application process.
- Must consult with local HUD office to ensure it is eligible to consolidate projects
- To apply: must submit separate renewal project application for each of the grants that are proposed to be consolidated, and an application for the new consolidated grant with the combined budget and information for all grants proposed for consolidation. Project applications that are proposed to be consolidated will be ranked and if all those grants are selected, HUD will award the single consolidated grant.

#### **Homeless households with children and youth defined as homeless under other federal statutes who are unstably housed.**

- Up to 10% of funding may be requested to serve homeless households with children and youth defined as homeless under other federal statutes who are unstably housed
- Only available to the following projects: Transitional Housing, Supportive Services Only, and Joint TH and PH-RRH component
- To be approved, CoC's must show that serving this population is of equal or greater priority (p.70)

  - f. Stoughton Area Resource Team
5. Funds for security deposits
  - a. Not a lot available
  - b. Could use County TBRA funds for security deposits, RFP comes out in April 2019, must be outside the City of Madison
