- Updates from: City, County, United Way, Youth Action Board, Lived Experience Council
  - City: In the budget process, will be finalizing in the next budget.
  - County: In the budget process, the County Board will be finalizing budget based on recommendations in next week's meeting. Recommendations on money for Dairy Drive. Working on 2024 contracts. Working on RFP's, finalizing contracts. Melissa Menning is working on overflow/cold weather options. Hired another housing specialist, Julian Stacey, working with TRC on the Evictions Prevention and Defense program.
- Youth Action Board: Needing more funding for the remaining of the year. The LGBTQ+ Center has a newer program; System Navigator which serves young adults and youth. Starting to gather information about what youth are experiencing and what support is needed; 4 youths have gained employment with the support from the program navigators. Currently waiting on transitional housing/rapid re-housing. There has been a delay in that starting due to needing an amendment through HUD.
- Lived Experience Council: No updates.
- Vote to approve Minutes from September 11, 2023–Chara Taylor
  - Minutes approved.
- Treasurer's Report Shanita Lawrence
  - Shanita had to make another presentation, Torrie gave the update of the budget and the current HSC fees.
- Presentation Policy for Approval of CoC Consolidated Application Torrie Kopp Mueller
  - Proposal Approve Policy for Approval of CoC Consolidated Application
    - Every year in the competition HUD requires the COC to post the application 48 hours before the deadline application. Suggests having a policy in place of how the application is approved.
    - Torrie created and went over 4 different options to vote on for new policy.
      - Option 1: Collaborative Applicant (City of Madison) approves.
      - Option 2: CoC Board Approves.
      - Option 3: CoC Membership approves.
      - Option 4: Core Committee approves.

Madison Street Medicine unable to take on the RRH and Voucher grant, review of signing letter to HUD to transfer the funds to different provider in the CoC. A few agencies have expressed interest in taking on the funding if the grant is approved to be reallocated.
