3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Tellurian ReachOut Housing First-Expansion is a permanent supportive housing project for chronically homeless individuals. This project operates under the Housing First model. This expansion project will add five (5) one-bedroom units for five individuals. Tellurian will secure and hold leases for scattered-site apartments in the community and provide Supportive Services.

The project will be supported by .7 FTE case manager and .1 supervision. 100% of participants will be chronically homeless as defined by HUD. Tellurian expects most of the current project participants would have dual diagnosis of mental health and substance use disorders, and some would have additional physical impairments due to long history of homelessness and not being able to care for their health.

While participation in Supportive Services is not required to stay in the program, it is a goal of Tellurian to help participants stabilize by providing regular contact and support. Tellurian will employ experienced and trained staff who are familiar with housing first philosophy, stages of change, motivational interviewing, harm reduction, and trauma-informed care models.

Staff has a goal of meeting with each participant in his/her apartment as often as needed, initially 3-4 times a week, and a minimum of once a week. The following services will be provided:

- Identification of participant's goal(s) in his/her own words and development of plans to achieve those goals;
- Identification of permanent housing that fits individual needs and advocacy with landlords;
- A thorough review of the lease;
- Life skills training, especially in the area of being a good tenant to achieve long-term housing stability;
- Individual assessment for mainstream benefits and assistance with those applications;
- Referral, linkage, and coordination of services with other service providers including mental health and substance use treatment, community support programs, primary and specialty health providers, employment assistance, payee, and life enriching activities;
- Transportation of participants to appointments with other supportive services in a staff vehicle or providing bus tickets;
- Financial counseling or budget planning.
