HUD recaptured \$28,769 due to a combination of staff changes/turnover and the slow filling of units during the first operating year. As the Coordinated Entry system continues to improve, we anticipate this will not be an issue moving forward.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Porchlight will provide permanent supportive housing (PSH) to 10 chronically homeless men and women. The PSH units are located on Thierer Road in newly constructed efficiency apartments. Supportive services are on-site and available to all participants. Participants will be offered the opportunity to develop an Individual Service Plan (ISP), incorporating short- and long-term goals they would like to accomplish. Porchlight will utilize a low-barrier model to entry, meaning the project allows entry to program participants with low or no income, current or past substance use, criminal records (including sex offenders) and history of domestic violence. In addition, this program will utilize a Housing First approach where supportive services will be offered, not required, and are based on the needs and desires of the program participants. The target population is adult men and women experiencing chronic homelessness and come from the top of the Priority list. All participants will come directly from the streets or shelter and will be selected from the Coordinated Entry Single PSH list (Porchlight staff are on the Housing Placement group) that prioritizes applicants based on length of homelessness, VI-SPDAT score, chronic homeless status, and veteran status. Participants are referred to the PSH priority list after completing a VI-SPDAT, which can be administered at assessment hubs through Coordinated Entry. Though not a prioritization, the program will give preference to veterans, if all other information is similar. The case manager will provide contact to participants on a daily basis. The case manager will provide participants transportation as needed to food pantries, doctor appointments, social security office, Dane County Job Center, etc. In addition, each participant will receive a monthly bus pass. Case management staff will be trained in harm reduction strategies and Housing First approaches.

Projected Outcomes:

- 80% or more of participants remain stable in PSH for at least one year or exit to a different permanent housing situation
- 75% of participants will maintain or increase their total income
