Presentation by Kayla and Takisha - Proposal to make changes to the Bylaws to support the work of the Lived experience Council and Dane County Youth Action Board

- Proposing to have membership dues from agencies
- Reason create income for folks with LE
- Having issues in past with maintain funding and compensate individuals
- Research other CoCs do something similar where they provide support to LE participants
- HSC does not currently collect dues
- Presented proposed dues for 2024
- Looked at other examples

Questions:

- → Who has to pay dues all agencies or just agencies who receive HUD CoC funding?
- → Who is a member and what is the value add if paying dues with limited budgets?
- → What is the value add of paying dues and being a member?
- → Can there be an alternative way to be a member without paying dues?

Comments/Feedback:

- → Examples from another CoC dues gave voting rights and the amounts were smaller, looking at housing budget rather than full organization
- → Don't think funders need to pay dues
- → Budgets don't have space for dues. What else could dues look like/how else can we fund this?
- → CoC funding may not be eligible to use for dues
- → Lots of agencies are tangential members w/o housing programs but work with homeless through different means and may choose not to be members and what that impact that would have

Exit Destinations

- Put together data points from the community and putting them out, let them know suggestions for other data
- Exits are captured at end of program asked to fill in where client is exiting to
- 3 categories: permanent destination, temporary destination, unknown destination
- Collect data from a variety of projects
- Majority are households w/o children (ex: single adults)
- Trendline: Covid funding in 2021 higher exits to permanency and has stayed a bit higher
- Marking "other" for exits kicks it out to unknown housing
- Collect as much data as we can because it goes on to get used in the community, but recognize that it is difficult to collect.
- Exit outcomes vary significantly by project and household type.
- Increase in resources positively impats housing outcomes.
- Data collection can be difficult but is important planning, funding, etc.

• Also note there are many individuals that self-resolve
