3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Pheasant Ridge Trail (PRT) is a permanent housing program for 16 formerly homeless persons with disabilities. PRT was a newly constructed apartment complex in 2006 utilizing HUD construction dollars. Porchlight has owned and managed the program since then. Rent is 30% of adjusted income and Porchlight provides residents monthly bus passes and intensive case management. All current participants have a documented disability and were literally homeless when they came into the program. All turnover units are prioritized for persons who are chronically homeless and will be taken from the Madison Coordinated Entry PSH list. PRT is close to public transportation and all residents are given a monthly bus pass. There are two on-site laundry facilities free for participants. Two of the units are handicap accessible. Residents are offered case management services in areas such as GED completion, AODA (alcohol and other drug abuse) counseling, physical and mental health counseling, health care counseling, skill development, employment/housing counseling, resume preparation, stress management, money management, housekeeping, tenant rights and responsibilities, and community referrals. Each participant develops an Individual Service Plan (ISP) with their case manager. This ISP incorporates short- and long- term goals the tenant would like to accomplish while in Porchlight housing. The ISP is monitored and updated quarterly. The case manager also assists in connecting the tenant to mainstream resources in the community such as health care, FoodShare, disability/veteran benefits and employment or training programs. The goal of Porchlight housing is to help the resident overcome any barriers that caused them to become homeless, to work on established goals, develop good tenant habits such as paying rent on time and good housekeeping, and to secure a steady income such as employment or disability and to maintain permanent housing with Porchlight or in the community.

Turnovers: 100% Chronically homeless men and women; written documentation of HUD defined chronic homelessness. 100% of Participants will come directly from the streets or emergency shelter. Participants will be selected from the Madison/Dane County Housing Priority list that prioritizes applicants based on length of homelessness, VI-SPDAT score, chronic status and veteran status.

Proposed outcomes:

- 80% or more of participants remain stable in PSH for at least one year or exit to a different permanent housing situation
- 75% of participants will maintain or increase their total income
