I.City of Madison Budget (Linette Rhodes) Manager at Community Development block grant funds

- A. Childcare, homelessness issues, community centers, senior center funding
- B. Process
- 1. Capital Budget comes from money borrowed from the bank that has to be paid back
- a. Staff kick off meeting march 21st, june 20th for operating budget process -increasing community costs, staff raises, usually starts with over 16million in the whole
- b. Linette will send out links to meetings
- c. Mayoral expectations (cost to continue)
 - 2. Agency requests due April 21st, July 21st
- a. Analyze proposals, Sept 5thmayor publishes her budget, she may take recommendations or add her own priorities, public health and community development have not had to take any cuts for the last 2 years
- 2. Public comment and feedback Sept 11th-good time to engage with elected officials, Oct 9t-good
- 3. Finance committee amendments Sept 26th, Oct 23rd
- a. Less then a million dollars for amendments
- b. After that money is gone money must be taken from some other source
- 4. Operating budget-make sure homelessness is rare and brief are in the budget
 - Affordable housing consumer lending
 - a. Affordable housing development projects
 - b. Permanent men's shelter
 - c. Reserve fund to maintain temporary shelters
 - d. Senior center building improvements
- 5. Special projects
- . Buy Salvation Army Darbo site to prepare to make a purpose-built shelter there for families and single women due date is July
- a. Youth-centered housing for youth exiting foster care system; seeking a developer and service partner; the City owns a site on Park Street that they hope to use
- b. Hotel conversion to "workforce housing" issuing a Request for Interest to see if any developers that are interested in partnering with the City to develop this
- c. \$11.6 million in homeless services-16% of community homelessness funding
- d. Temporary men's shelter operation budget, \$584,000 2019, 2.4 million 2022 primarily still funded with stimulus dollars, how will this affect future purpose built shelters, funding is running out, it was stretched more people are using the shelter because people feel the services are better
- e. Dairy Drive campground funded on purely stimulus dollars, it was ment to be funded for 2 years, need to figure out how it will move forward
 - B. Opportunities for advocacy
 - 1. Send advocacy list to City staff
 - 1. Get to know your elected officials, especially alders on city county homeless issues committee
 - 2. We should keep an eye on who the new elected officials will be and educate them on why certain things should be on the budget

- 3. Sign up for public comment at finance committee or common council-some times meetings can last too long and many people say the same things
- 4. Write letters of support
- B. Women's shelter not as funded by stimulus money
- C. Linette has money for Potential project for a developer to purchase a structure and convert it into affordable housing
 - D. Matt will work on work group scheduling and facilitating
 - II. Committee Procedures

 - 1. Official procedures for committee leadership roles
- a. The HSC provides no specific guidance we can make up our own rules
