### 1. Review Commitment Survey Results

## 2. Review Quantitative Data: Race Equity Findings

- Group reviewed ppt (see email)
- Open Questions & Initial Reaction
  - Access to PSH (Deeper dive needed)
    - Torrie → Households with children are more often black households, possibly related to currently serving more RRH for families than Single Adults
    - Johnisha → Length of homeless (being incarcerated for 90+days, you lose your PSH status)
      - "I bring it up due to Black people having a higher incarceration rate in Dane County jail system (systemic disparities) - so would an issue like that impact LOT homeless and thus access to PSH."
    - Sarah → PSH
      - Look at household types around access rate: higher for white singles, but not minority families
      - New system (3-5yrs) and some people may have been grandfathered
  - Sarah: Leading the "reimaging CE workgroup" w/ LEC (Any recommendation from HB)
  - To what extent can this data help us move that workgroup forward?
    - Mihir: black people → Prevention and Diversion? Which may compliment the CoC and other components of the greater system of care.
  - Interesting Part: RRH and PSH → how it relates.
    - o High rate of access to RRH due to lower access to PSH?
  - Johneisha: How does this compare to past analysis?
    - Brenda: 10 years ago, black people were 12x likely to experience v.
      8 x
    - Mihir: From 2015 to 2021 (50-53%) there has been a slight decrease in black homelessness, and it doesn't seem like there are COVID deaths and blacks.
    - Torrie via chat: "The analysis that ICA did a few years ago showed that black people were 23 times more likely to experience homelessness."
    - Johneisha via chat: "Could it also be a false lens on improvements after all of the COVID relief funding."
    - Patrick: Who is entering homelessness is the biggest disparity: CE,



#### ER shelter vs. RRH/PSH

- Question becomes, what data are we comparing to determine and establish disparity?
- Johneisha: Hard to show systemic barriers re: access to healthcare, incarceration rates, etc. in terms of who is accessing PSH because of COVID funding.
  - Mihir: There's a baseline that we can look at, but definitely something to be aware of
- Jani: what other data sources are being reviewed, specifically as a school district we look at a broader definition of homelessness as does Early Childhood data and Head staff and RHY.
  - Torrie: DPI report, school district data for Dane County, 211
- Sarah: Our specific county's COVID response was heavily toward single households, more hotel programming for families, but otherwise majority were for singles.
  - Lots of efforts to address unsheltered homelessness which are more largely white.
  - Should look at pre-COVID numbers.

### 3. Qualitative Data Planning Discussion

- Homebase has been reviewing initial data and existing docs, policies and procedures, etc.
- Working with County and City to come up with initial qual data overview
  - 3-5 Focus Groups
  - 10-15 interviews
  - Survey
- Qual follow-up questions:
  - Why decrease in black homelessness last year?
  - Why would there be an undercount of Latinx in PIT?
  - Does access of PSH (black households are lower) line up with what you know of the system? Why would that be?
    - Families that go into RRH when they need PSH
