Lutheran Social Services notified the CoC on August 21, 2023 that they were voluntarily reallocating their funds and would not seek renewal. They indicated the following reasons for not seeking renewal: difficulty in hiring/staffing in this market, difficulty spending down the funds due to issues securing affordable housing in Dane County, the high cost of living in Dane County has made it hard for clients to continue paying their rent beyond housing assistance, and past difficulties administering the program creating current challenges that have been hard to overcome.
