### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Tellurian HOPE is a permanent supportive housing program for chronically homeless individuals based on the Housing First model.

The project can provide scattered-site housing and supportive services for eight (8) individuals. Tellurian holds leases for six (6) one-bedroom apartments and two (2) efficiencies. Supportive services are provided by a 1.1 FTE case manager and .1 Supervisor.

100% of participants will be 1) chronically homeless as defined by HUD, and 2) come from the streets or other locations not meant for human habitation, emergency shelters, or safe haven. Since the project's start, Tellurian HOPE has prioritized those with longest length of homelessness and most severe needs by going through the Madison/Dane County Single Housing Priority List from the top. The project has been successful with housing some of the most chronically homeless persons in the community.

Proposed outcomes are as follows: 1) 75% of the participants will remain in permanent housing as of the end of the operating year or exiting to permanent housing during the operating year; 2) 88% of the participants will maintain or increase their total income from all sources as of the end of the operating year or program exit.
