Community Action Coalition has been operating its supportive housing programs in Dane County since 2012. Program enrollees are either residing in an emergency shelter or in a hotel/motel on a shelter voucher or are living in a place not meant for human habitation. The program’s funding allows CAC to pay the entire rent for up to twenty four months so the participant can work towards financial independence.
