The Road Home has administered CoC grants for the past 15 years. We have been the applicant on three separate programs and a sub-recipient for two additional programs. The Road Home has 20 years of experience performing housing-related services such as rental assistance and support services to homeless families in Dane County. Our agency has experience in CoC funded and non-CoC funded PSH projects, including scattered-site and congregate site models. Given our experience, including landlord recruitment, we feel we can get the project started by August, 2020.

The Road Home has successfully administered HUD grants in the past, has successfully secured matching funds and has a good financial system in place. We have no unresolved findings from HUD audits and we are familiar with eLCOCCSS.

The Road Home has a good working relationship with our local United Way, City, County and partner agencies. As stated above with matching requirements, we also have experience with leveraging dollars.

The Road Home contracts with Numbers 4 Nonprofits (N4N) for all accounting matters. The accountants have over 20 years of experience. We work directly with a Senior Accountant and her work is overseen by the founder. Both are CPAs. The financial accounting system used to administer the grant is QuickBooks. Internal coordination is smooth and no financial audit findings have occurred.

WI0098L5I031811 is a transitional housing program that serves youth-led households and is not being renewed. We have secured local private funding to continue this program. Program participants will not become homeless or be affected in any other way due to the funding source change. The new proposed program, Foundations, will increase our community's PSH stock. Foundations hopes to start August 1, 2020, have staff hired within 30 days, have participants enrolled within 30 days, begin moving families in within 60 days and be all leased up within 120 days.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Through our coordinated entry housing priority list, there are approximately 130 families and 31 chronically homeless families needing permanent supportive housing. About two-thirds of our community's permanent supportive housing stock is congregate housing managed by two different property management companies. If a family with high needs is not successful in one of these units, it severely limits their options for the necessary support services they need. We believe more scattered-site choices for families are needed to help families maintain permanent housing. The Road Home is currently a subrecipient for House-ability, another CoC-funded PSH program. This program uses a scattered-site model and is always full. Foundations will add to this capacity by serving at least five extremely low-income (<30% CMI) homeless families who have at least one adult with a disability in a scattered-site model. Foundations will follow principles of Housing First, including not requiring income or sobriety.

The Road Home will do outreach to private landlords throughout Dane County to develop partnerships to quickly house chronically homeless families with an initial one-year lease. The program will pay the security deposit and 100% of the rent to landlords, and program participants will then pay 30% of their income for program fees. As an additional incentive to landlords, the program will pay up to one month's rent in damages. Foundations will provide housing location assistance to families and case management services to help families and landlord work together. The case manager will also work with families on housing stability goals, including but not limited to increasing income, connecting to mainstream benefits and other client-defined goals (e.g budgeting), all leading toward family self-sufficiency and stability. Case management will be voluntary for participants but we will continue to reach out to them on a regular basis to offer support.

As Foundations will be a part of our CoC, the program will follow our community's written standards as it pertains to permanent supportive housing. This includes taking families with high acuity from our community's housing priority list. If a family is faced with eviction, we will work to rehouse them with a different landlord in the community and prevent another episode of homelessness as much as possible.

Families will be identified through our CE priority list & community placement meeting. Once eligibility is established, staff will complete a Housing Location Worksheet which will identify preferences on location, barriers to housing & any necessary accommodations. Staff will utilize our list of private landlords as well as our community-generated landlord list to develop ongoing housing opportunities for participants.

Once housing is located and an initial year-lease is signed, the program will pay the security deposit, which will shorten the family's length of homelessness. After that, the program will pay 100% of the rent directly to the landlord, which provides a safety net for families.

Case managers will meet with families as needed to identify housing specific goals, including understanding the lease, collaborating with the landlord around any issues that might arise, skill-building around budgeting for rent and utilities, and assisting with increasing income.

3. What specific plan does this project have to specifically coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible?

Program staff will complete a Mainstream Resource checklist with each participant to determine which resources a family might be eligible. have established partnerships with DVR, our local Job Center and other employment & training programs to refer families that may qualify for their services.

The Second Chance Apartment Project is seeking renewal funds. The program is a partnership with YWCA Madison and sponsors that provide supported, transitional housing for homeless families with children. This program prioritizes youth-led homeless households (Adults aged 18-24) since this meets a need in our community and is one of the subpopulations HUD suggests is appropriate for TH. There are currently 25 homeless families in our community with a head of household between 18-24 years old.

The program recruits sponsors including businesses, individuals, congregations, and the public sector. A sponsor pays the rent for a market rate apartment for up to two years and also provides volunteer mentors to work with program participants, necessary furnishings, and assistance with moving. The sponsors' commitment allows us to rent an otherwise market rate apartment to a homeless family at an affordable, subsidized rent equal to 30% of the family's adjusted gross income. All participants must be homeless at the time of program entry. Families are accepted from the housing priority list, where they are added after completing a VI-SPDAT.

Once placed in a Second Chance apartment, a family pays 30% of their adjusted gross income as a program fee. 20% of the fee is placed into a program Emergency Fund. 80% of the fee is placed into an Individual Development Account (IDA) for the family. IDA funds may be used by the family while in the program to assist with expenses related to goals set by the family with their Case Manager, but not for ordinary items in the monthly budget. Upon leaving the program, families may use their IDAs for move-in costs, rent payments, or other CoC-eligible expenses.

The Road Home provides case management services to help a family identify and reach goals that will lead to increased income and permanent housing. The Road Home also provides training and ongoing support to the volunteer mentors who complement the work of the Case Managers and provides additional support to families. Case Managers and mentors offer weekly home visits to each family in the program to work on goal related activities. Quarterly goal planning involves the family and Case Manager and result in a set of negotiated goals that will help the family meet a range of needs. In addition to permanent housing, goals may include: access to mainstream and community resources and benefits; increased income; improved credit; educational goals and others.

The YWCA provides a Program Coordinator who fulfills the property management responsibilities including participant housing placement, calculating and collecting fees, completing program contracts with participants, enforcing contract guidelines, working with the property owners, and administering the IDA accounts.
