- → Tier 1 and Tier 2 assessment system done. Still to look at Tier 2 assessment tool.

- → What are shelter priority services at community services?
 - Mental health or recovery services. Porchlight is making connections to get people connected to outpatient treatment services. Peer support can be used for mental health support, too.
 - General resources computer, phone, printer, etc. People come to JFF office, not going all the way to downtown, needing a computer access to do job applications, need to make a phone call to my PO, basic time and space, not too rigid
 - Group facilitator who can help with creating and being in a community when they find housing – presence of people with lived experience/peer support who can lead the group conversation, etc. People need to have a community when they have housing. Making a community outside of the shelter is important.
 - Housing readiness specialist prepare people to maintain housing. Have some difficult conversations up front. Go over expectations of the housing lease. Work on preventing return to homelessness. Connect people to CCS, so people can have long term support and success. Life skills. People get housing and then they come back.
 - ADRC and CCS connection

- 3. System Flow- Singles Shelter Conversation/Brainstorm

Sarah Lim shared the draft chart below to introduce the next meeting discussion on the singles system flow. There are many ways to group shelter participants for targeted services such as age or how long they have used the shelter. In the chart below, we are using the Reimagine Coordinated Entry RRH and PSH target population – those who will be prioritized and those who are not. We will discuss at the next meeting, from what services the different groups would benefit the most and who could provide the services, starting from newly homeless population. After discussing the system flow and services for singles, we will move to family system discussion.

 - Healing House has four open rooms right now, two pending referrals.

- Porchlight Men's Shelter averaged 284 guests per night in May, w/ 616 unduplicated guest during that month. Currently, we are serving on average about 270 a night. Clients are getting housed and we are planning for the permanent shelter
- TSA: Women's Shelter has 90 women that last. Family Shelter we had 31 Families and have 7 families scheduled to come into Family Shelter this week
- Safe Haven averaged 42 guests per day in May, w/ 141 unduplicated guests during that month.
- YWCA shelter-30 residents 1 unit vacant not ready-2pending referrals
- Beacon Updates
