The Housing First Leasing Project(HFLP) is a permanent housing program with supportive services for chronically homeless men and women. Porchlight has been operating the program since 2009. Porchlight leases 12 efficiency or one-bedroom apartments from landlords in the community and then sub-leases them to participants. The housing units are located throughout Madison and Middleton and are close to public transportation, grocery stores, laundromats, and health care. Participants also receive a monthly bus pass. Participants pay 30% of their income for rent. Supportive services are voluntary and involve the creation of an Individualized Service Plan (ISP) which incorporates short- and long-term goals participants would like to accomplish.

All program participants without an income will be assisted in applying for disability benefits (SSI/SSDI) as appropriate. Appointments will be made with Toni Bender (homeless liaison) at the Social Security Administration. 
